**“AN ORDER RECONSTITUTING THE TAPAZ PUBLIC-PRIVATE
PARTNERSHIP SELECTION COMMITTEE (PPP-SC)”**

WHEREAS, The people’s right to effective and reasonable participation and public trust provision under Section 16, Article XIII and Section 1, Article XI, respectively, of the 1987 Constitution guarantee and empower civil society groups to have effective and meaningful participation in the regulation and management of PPP projects;

WHEREAS, under Section 20, Article II of the 1987 Constitution, the “State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments”;

WHEREAS, Section 22 (c) of the 1991 LGC states that no contract may be entered into by the Mayor on behalf of the Municipality without prior authorization by the Sangguniang Bayan. The participation of the sanggunian is indispensable in the adoption and implementation of a PPP arrangement;

WHEREAS, the private sector participates in infrastructure, development and social service-related projects of the State and local government units (LGUs) through what is popularly known as Public-Private Partnerships (PPPs);

WHEREAS, Section 14 of the Tapaz Public-Private Partnership Code of 2018, a PPP Selection Committee (PPP-SC) for purposes of selecting a PSP for a specific PPP Project shall be created;

NOW THEREFORE, I, ROBERTO O. PALOMAR, *Municipal Mayor* of the Municipality of Tapaz, Capiz, Philippines, by virtue of the power vested in me by law as the Local Chief Executive, do hereby order **“AN ORDER CONSTITUTING THE TAPAZ PUBLIC-PRIVATE PARTNERSHIP SELECTION COMMITTEE (PPP-SC) ITS TECHNICAL WORKING GROUP AND SUPPORT STAFF”** to be composed of the following:
