RE-CONSITUTING THE TAPAZ LOCAL HEALTH BOARD

WHEREAS, RA 7160 mandates a creation of a Local Health Board;
WHEREAS, it is material to the promotion of the welfare of the people to maintain a health program;
WHEREAS, the Board was created to pursue, direct and monitor the health programs of our municipality;
WHEREAS, the re-constitution of the Tapaz Local Health Board has become necessary in compliance with RA 7160 as there is a new set of municipal officials;

NOW THEREFORE, I, **ROBERTO O. PALOMAR**, Municipal Mayor of Tapaz, Capiz, by virtue of the power vested in me by law, hereby issue and promulgate this order;

Section 1. There is re-constituted in Tapaz, Capiz, a Local Health Board.


Section 3, Functions- The municipal health board shall:

- (1) Propose to the Sanggunian Bayan concerned, in accordance with the standards and criteria set by DOH, annual budgetary allocations for the operations and maintenance of health facilities and services within the municipality, as the case may be;
- (2) Serve as an advisory committee to the Sanggunian Bayan concerned on health matters such, as, but not limited to, the necessity for, and application of local appropriations for public health purposes; and
- (3) Create committees which shall advise, local health agencies on matters such as, but not limited to, technical and administrative standards of DOH, personnel selection and promotions, bids and awards, grievance and complaints, personnel discipline, budget, review, operations review and similar functions.

Section 4. This order takes effect immediately and shall remain in effect until repealed.

This order rescinds all other issuances inconsistent with the foregoing.
