### RECONSTITUTING THE TAPAZ MUNICIPAL DEVELOPMENT COUNCIL

**WHEREAS**, Title six section 106 of the Local Government Code is the Local Development Council which paragraph (a) states that each local government unit shall have a comprehensive multi- sectoral development plan to be initiated by its development council and approved by its sanggunian;

**NOW THEREFORE, I, HON. ROBERTO O. PALOMAR**, Municipal Mayor, Municipality of Tapaz, Province of Capiz by virtue of the powers vested in me by law, do hereby order;

**Section 3. Power and function of the Tapaz Municipal Development Council shall:**

1. Formulate long- term, medium-term and annual socio-economic development plans and policies;
2. Formulate medium- term and annual public investment programs;
3. Evaluate and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects; and
6. Perform such other functions as may be provided by law or competent authority.

**Section 4. The Secretariat**

The Secretariat of the Tapaz Municipal Development Council shall be headed by the Municipal Planning and Development Coordinator.

**Section 5. Effectivity**

This order shall take effect immediately and remain in force until rescinded.
