**Executive Order No. 20-03-11**

**"IMPOSITION OF CURFEW IN THE MUNICIPALITY OF TAPAZ"**

**WHEREAS**, President Rodrigo Roa Duterte on March 8, 2020 issued Proclamation No. 922 declaring the country under the *State of National Health Emergency*, and the World Health Organization (WHO) already declared CoVid-19 as a public health emergency of international concern;

**WHEREAS**, the number of infected persons and the number of death because of CoVid-19 continue to increase in the country;

**WHEREAS**, preventive measures are already imposed by the Local Government Unit of Tapaz through Executive Order No. 20-03-10, Series of March 13, 2020 so to safeguard the residents against the spread of the disease;

**WHEREAS**, there exist need to declare curfew for the entire municipality to limit the activity of the population and avoid the conduct of unsafe and risky night time activities;

**NOW THEREFORE, I, ROBERTO O. PALOMAR**, *Municipal Mayor* of the Municipality of Tapaz, Capiz, Philippines, by virtue of the power vested in me by law as the Local Chief Executive, do hereby order **"IMPOSITION OF CURFEW IN THE MUNICIPALITY OF TAPAZ"**, to wit:

**Section 1:** All residents are prohibited to roam around and/or stay in public places, alleys, restaurant, videoke bar, entertainment areas from 9 o'clock in the evening until 4 o'clock in the morning;

**Section 2:** During the curfew hours, unnecessary travel within the municipality will be restricted to allow the public to stay at home and avoid physical social contact with other residents.

**Section 3:** Likewise, stores, establishments and other related entertainment business is ordered to shut down during the period covered by the curfew hours;

**Section 4:** Any person caught violating this curfew shall be brought to an isolation quarter for proper identification and possible quarantine in case he/she manifest symptoms of CoVid-19;

**Section 5:** The Tapaz Municipal Police Station, Tapaz Security Force, the Barangay Police Action Team, and other auxiliary security forces is hereby ordered to impose this order effective immediately;

**Section 6:** This order shall be valid effective to date, March 16, 2020 and until lifted through an order by this office;

**FURTHERMORE**, let copies of this Executive Order be furnished to all concerned for their information and guidance.
