**"INSTITUTING PREVENTIVE MEASURES AGAINST COVID-19"**

**WHEREAS**, President Rodrigo Roa Duterte on March 8, 2020 issued Proclamation No. 922 declaring the country under the *State of National Health Emergency*, and the World Health Organization (WHO) already declared CoVID-19 as a public health emergency of international concern;

**WHEREAS**, all government agencies and local government unit are enjoined to render full assistance and cooperation and mobilize necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the CoVid-19 threat;

**WHEREAS**, it is paramount importance to impose urgent and critical measures to contain or prevent the spread of CoVid-19 for the welfare and protection of the residents of the municipality;

**NOW THEREFORE, I, ROBERTO O. PALOMAR**, *Municipal Mayor* of the Municipality of Tapaz, Capiz, Philippines, by virtue of the power vested in me by law as the Local Chief Executive, do hereby order **"INSTITUTING PREVENTIVE MEASURES AGAINST COVID-19"**, to wit:

**Section 1:** All residents are encouraged to practice proper hygiene by constant hand washing, covering their mouth and nose when coughing, and to adopt social-distancing measures by staying at home and avoid staying in public places for a longer period of time;

**Section 2:** Public gatherings, events, graduations rites, moving up, fiesta, and other ceremony in any part of the municipality is hereby prohibited until further notice.

**Section 3:** Domestic and international tourists, as well as balikbayans are ordered to disclose their travel history and required to register at the Public Transport Terminal for proper monitoring;

**Section 4:** Disinfection areas shall be established in public places such as but not limited to public market, transport terminal, schools, government offices, and other public buildings;

**Section 5:** Officials of the barangays are assigned to monitor and immediately report any residents which shows signs and symptoms of CoVid-19;

**Section 6:** The Philippine National Police is tasked to coordinate with the Municipal Health Office to strictly impose the quarantine of the persons considered as Persons Under Monitoring (PUM), Persons Under Investigation (PUI), and confirmed patients with CoVid-19.

**Section 7:** Price of goods and commodities shall be stringently monitored to avoid overpricing and conform with the existing standard retail prices.

Section 8: Transport of basic food commodities over one (1) ton shall require transport clearance from the Municipal Agriculture Office without cost to prevent sudden disruption of supply and avoid food shortage;

FURTHERMORE, let copies of this Executive Order be furnished to all concerned for their information and guidance.
